

# Penang Smart Parking 'Merdeka Promo' 2021

---

1. This Penang Smart Parking (PSP) Merdeka Promo 2021 (the "**Promotion**") is valid from 25 August to 8 September 2021, both dates inclusive ("**Promotion Period**"). By participating in this Promotion, user agree to be bound by these terms.
2. The Promotion is open to first 6,400 existing users of the PSP app who, during the Promotion Period, successfully reloads a minimum amount of RM20.00 into his/her PSP e-wallet and/or
3. First 6,400 existing users of the PSP app who, during the Promotion Period, successfully purchase September 2021 Monthly pass.

## **Cashback To Be Received By The Users**

4. If Clauses 1 and 2 stipulated above are fulfilled, the existing users will receive 10% of reloads amount cashback into his/her PSP e-wallet, limited to RM200 reloads.
5. If Clauses 1 and 3 stipulated above are fulfilled, the existing users will receive RM5.00 cashback into his/her PSP e-wallet.
6. Users are entitled to redeem their cashback for one time only per registered phone number.

## **Crediting of Cashback**

7. The Cashback will be credited within 14 working days from the promotion period ends.
8. PSP reserves the right to:
  - a) decline to credit the Cashback to the users, in the event that the PSP determines that any of the requirements or the terms had not been complied with, including but not limited to the following:
    - i. where the Existing Customer has acted fraudulently or dishonestly;

- ii. where the Existing Customer had conducted himself / herself in bad faith or otherwise in an inappropriate manner to gain an unfair advantage against PSP.

### **General**

9. PSP reserves the right to determine at its sole and absolute discretion all matters arising out of or in connection with the Promotion. PSP's determination of all matters relating to this Promotion shall be final and conclusive and no correspondence will be entertained.
10. PSP further reserves the right to do any of the following at any time without prior notice:
  - a) make any changes to the Promotion and/or replace the Cashback with another reward of equivalent or similar value; or
  - b) vary, modify, add, delete or otherwise revise any of these terms and conditions, including termination or withdrawing the Promotion, or to extend or shorten the Promotion Period at any time at PSP's sole discretion, with or without prior notice or reason.
  - c) You understand and agree to be bound by any variation to these terms.
11. In the event of any inconsistency between these terms and conditions and any brochures, marketing or promotional materials relating to the Promotion, these terms and conditions shall prevail to the extent of such inconsistency.
